

04 Fundraising

1. Grants

- a) FSANT members and FSANT may apply for grants from organisations whose ethics and objectives do not conflict with those of FSANT, ISA or the ISU.
- b) FSANT members are required to submit all grant applications to FSANT for endorsement.
- c) All applications will be considered at either a committee meeting or by consensus email if time constraints apply.
- d) In exceptional circumstances members of the FSANT executive may apply on behalf of FSANT. This application must be ratified at the next Committee meeting.
- e) If necessary, FSANT will rank grant applications.
- f) Applications from coaches that require FSANT endorsement will only be considered if they do not conflict with an application from a skater.
- g) Skater Financial Assistance for National Competition Attendance
 1. FSANT members competing at the Australian Figure Skating Championships from Basic Novice 1 level and above may apply for financial assistance to offset travel and competition-related expenses.
 2. FSANT members competing at the Australian Adult Figure Skating Championships from Bronze level and above may apply for financial assistance to offset travel and competition-related expenses.
 3. Applicants must have been financial FSANT members for at least 12 consecutive months prior to the application.
 4. Applicants must have demonstrated support for FSANT fundraising activities in the 12 months prior to the application (where applicable).
 5. Financial assistance will be considered for one national-level competition per ISU season.
 6. Funding amounts will be determined annually and may vary by level:

Competition Level	Maximum Funding per competition season
Basic Novice / Adult Bronze or above	\$300

Applications must include:
 - Proof of event registration
 - A brief statement of need
 - A brief statement of how the skater will acknowledge the financial support
 - A summary of recent skating achievements
 7. All applications will be reviewed by the FSANT Committee and ranked if necessary.
 8. Priority will be given to skaters who demonstrate commitment to training, sportsmanship, and alignment with FSANT values.
 9. FSANT reserves the right to adjust funding levels based on available resources and the number of applicants.

2. Sponsorships

- a) FSANT members and FSANT may accept sponsorship from organisations whose ethics and objectives do not conflict with those of FSANT, ISA or the ISU.
- b) FSANT members are required to seek approval from FSANT prior to accepting any sponsorship.
- c) All applications will be considered at a Committee meeting.
- d) In exceptional circumstances members of the FSANT Committee may approve a sponsorship on behalf of FSANT. This approval must be ratified at the next Committee meeting.
- e) Any conditions of sponsorship must not conflict with the constitution, regulations, policies or objectives of FSANT, ISA or the ISU.

3. Fundraising

- a) FSANT and its members may participate in any fundraising activities that do not conflict with the ethics and objectives of FSANT, ISA or the ISU.
- b) FSANT members are required to seek approval from FSANT prior to any fundraising activity where the sport of figure skating is advertised by any means including posters, photographs or clothing.
- c) FSANT members are not required to give FSANT any proceeds from their fundraising.
- d) Unless approval is given, any money earned by any means as fundraising for FSANT must be properly acquitted and paid in full into the FSANT account prior to the deduction of any expenses.
- e) Expenditure to purchase items for any fundraising activity must have the prior approval of the Committee.
- f) Fundraising money shall be for the benefit of as many skating members as possible and the FSANT Committee shall have the final say how it is used.

4. Donations

- a) Donations may include but are not limited to money, goods, services and vouchers.
- b) Affiliated clubs, FSANT members and FSANT may accept donations from any organisation or individual whose ethics and objectives do not conflict with the ethics and objectives of FSANT, ISA or the ISU.
- c) Any conditions of donation must not conflict with the constitution, regulations, policies or objectives of FSANT, ISA or the ISU.
- d) Unless a specific purpose is defined by the donor, donations shall be for the benefit of as many skating members as possible and the Committee shall have the final say how it is used.
